Welcome, Introductions, Agenda Review

Dr. Holt, welcomed the board and participants to the meeting and provided an overview of the agenda and the phone numbers for public comment and technical assistance.

Dr. Holt reminded committee members of the 7 Principles of Agreement to guide their participation in the meeting.

Public Comments

Three comments were submitted to the HAAB by email and voicemail prior to the meeting. These comments are included as an attachment to this document.

Sharon Nasset called on behalf of the organization Third Bridge Now. Sharon thanked HAAB members for their board participation, asked for people to review the Third Bridge Now proposed design solution and called for meetings to be in person.

One caller was unable to connect.

Project Updates

Dr. Holt welcomed Erika McCalpine, ODOT's Assistant Director for Social Equity, to share information. Erika M. gave updates on behalf of Project Director Megan Channell.

 Erika M. showed the new project timeline, explaining that based on current funding, ODOT's priorities will be to complete the environmental review process, advance Early Work Packages A, B and C to 100% design, and advance the Main Construction Package to 30% design.

Dr. Holt reviewed the updated HAAB Meeting Schedule, explaining that there are opportunities to engage every month.

- Dr. Holt asked whether HAAB members had a preference for meeting on the second or fourth Tuesday of the month.
- » The general consensus was to meet on the second Tuesday.

Dr. Holt reviewed the Anticipated Meeting Topics for the coming months.



- James Posey requested more information on these topics, including budgets and how they fit into ODOT's larger efforts with equity communities.
- » Erika M. responded that this conversation will be a part of the next HAAB meeting agenda.
- Keith Edwards asked if the list was in order of priority and requested that it be sorted, highlighting important milestones.
- » Kerry Werner, an ODOT Resident Engineer, confirmed that it is a comprehensive list, but not in any specific order and many items will be worked on simultaneously.
- » Kevin Modica requested a project management spreadsheet or Gantt chart be shared with HAAB members.

Erika M. provided an update on a recent project tour led by the Urban Mobility Office for Senator Lew Frederick and Senator Nancy Nathanson, the co-chairs of the recently formed special legislative subcommittee on transportation planning. The I-5 Rose Quarter Improvement Project team presented for 45 minutes about what the project includes and how community engagement and the Independent Highway Cover Assessment process supported the current design.

Dr. Holt followed up with an update about a project tour with the FHWA Administrator Shailen Bhatt, in partnership with Albina Vision Trust and the City of Portland.

Dr. Holt then shared an opportunity for the HAAB to submit a comment on Metro's 2023 Regional Transportation Plan, saying that information about the plan and the I-5 Rose Quarter Improvement Project's role in it would be emailed after the meeting.

Dr. Holt asked for questions.

Design Updates

Dr. Holt invited Kerry Werner to present on Design Updates. Kerry presented the updated project improvements map, featuring changes based on several months of working with the community and HAAB.

- Kerry described the changes to the I-5 southbound exit ramp, now known as the "Flyover." Previously, all traffic exiting I-5 would have been routed up N. Wheeler Avenue. Now, eastbound traffic will take the Flyover to NE Weidler, and westbound traffic will either route up N. Wheeler Avenue or N. Ramsay Way. About 2/3 of drivers will be heading eastbound using the flyover.
- » Current work includes deciding whether Wheeler Ave or Ramsay Way will be the final design option for westbound traffic.
- The other new feature is the Bicycle and Pedestrian Bridge over I-5 south of the flyover.



Kerry explained how these changes were made in response to public comments during the Supplemental Environmental Assessment (SEA).

Kerry covered next steps, including updating the SEA, receiving a decision from the FHWA and advancing the Community Framework Agreement process in partnership with the City of Portland.

Kerry asked for questions.

- Kevin asked if there is a more detailed model of what the Flyover will look like.
- » Kerry offered to provide a different image with a clearer 3D depiction at a future meeting.
- John Washington asked if the Flyover solution addresses concerns about traffic and pedestrians near the Moda Center intersection in the previous design.
- » Kerry confirmed that it does.
- James Posey asked about the integration of this work with Metro and other city projects, specifically around homeless services. Others elaborated on the concern.
- » Kerry offered to look into the intersectionality of citywide concerns with the I-5 Rose Quarter Improvement Project design specifically.
- Dr. Holt reiterated that this concern and other human element topics could be included in future meetings.

Reconnecting Communities & Neighborhoods Grant

Dr. Holt asked Mike Baker, Project Manager with the I-5 Rose Quarter Improvement Project's Owner Representative team, to present. Mike B. reminded everyone of what happened with last year's grant application and what to expect this year.

- Out of 435 applications, about 10% of all grant requests received an award. This
 project was one of the top applications. The project team received positive
 feedback and were highly encouraged to apply again.
- Last year there was \$145 million available, this year there's \$3.4 billion due to two different programs being combined.
- The deadline for submission is September 28, 2023.
- This project is located in two census tracts that meet a designation as either disadvantaged or underserved. As a result, the project is not required to come up with matching funding for the grant request and there is no maximum ask. There is no penalty for a maximum ask. The minimum award is \$5 million.
- Applications showing strong regional partnerships will do better. An important component is letters of support, which the project team will be asking for soon.



- If awarded, the project would be considered a highly-rated project, meaning it would be easier to receive grant funding from other sources.
- Overall, the project team thinks the strength and quality of last year's grant will carry forward.
- Award announcements are expected in Spring 2024.

Kevin asked if HAAB members could see a draft copy of the grant application.

Mike B. confirmed yes.

Mike B. reviewed the ODOT Application Options chart, pointing out the three different asks ODOT could make, noting that none of the asks cover the entire cost of the project. ODOT is willing to back any one of these options and is seeking the HAAB's input.

- Bryson Davis asked whether each component could be funded individually and whether certain components could be built independently of one another.
- » Mike B. said it's common not to receive full funding and that the government most likely will not specify what components of the project the funds must be used for.
- » Kerry confirmed that elements could be built independently, but that the highway cover will have the greatest impact on other elements.

Dr. Holt then turned the presentation over to Mike Serritella with the City of Portland. Mike S. stressed the unique nature of this grant opportunity and described a grant application the City will be submitting to complement the work of the I-5 Rose Quarter Improvement Project. The city's project will be to improve Broadway as a nexus between several citywide projects, including Rose Quarter.

Dr. Holt asked for questions.

- Cleo Davis asked which of the three grant options included auxiliary lane and shoulder work on I-5.
- » Option 1 was confirmed.
- A representative from the City of Portland asked for a further breakdown of the \$500 million highway cover cost.
- » Kerry identified some of the things that would be covered under the budget, including the sub-structure, girders and more. Additionally, a fire suppression and evacuation system must be included. Kerry explained that work on the highway itself is separated out from the cover because there are other grant opportunities better suited for that work.
- James Posey expressed concern about ensuring that the grant will truly represent economic benefits for the Black community.



- Dr. Carlos Richard added concern about the term "Reconnecting Communities" and which communities we're referring to, as well as the distribution of funds if the grant is received to other community needs.
- Keith Edwards emphasized the importance of differentiating between the needs of the I-5 Rose Quarter Improvement Project and Albina Vision Trust.
- Bryson reiterated concerns about asking for too much money and a desire to be clearer with realistic, but ambitious asks.

At 5:30 pm, the originally scheduled end time, Dr. Holt paused the meeting to confirm that everyone was okay with continuing the discussion so HAAB members could vote on the available package options.

 Kevin responded to Bryson, reiterating that any grant amount will lead to more opportunities and showed support for pursuing funding, including the long shots.

Ericka Warren, HAAB Facilitator offered to reach out to members not in attendance and get their votes to add to the total.

Mike B. expanded on what would happen if the project didn't receive any grant funding and what would happen if it received partial funding. He noted that if the project receives partial funding from this grant opportunity, it will be better positioned to receive more from the state budget. Mike B. also restated that the project does not need to have a full funding plan prepared to apply for the grant.

Kevin asked for consensus on option selection, while also requesting more detail from ODOT about how funding that is received would be used.

Next Steps

Dr. Holt thanked everyone for joining and said that the next meeting date would be announced soon.
