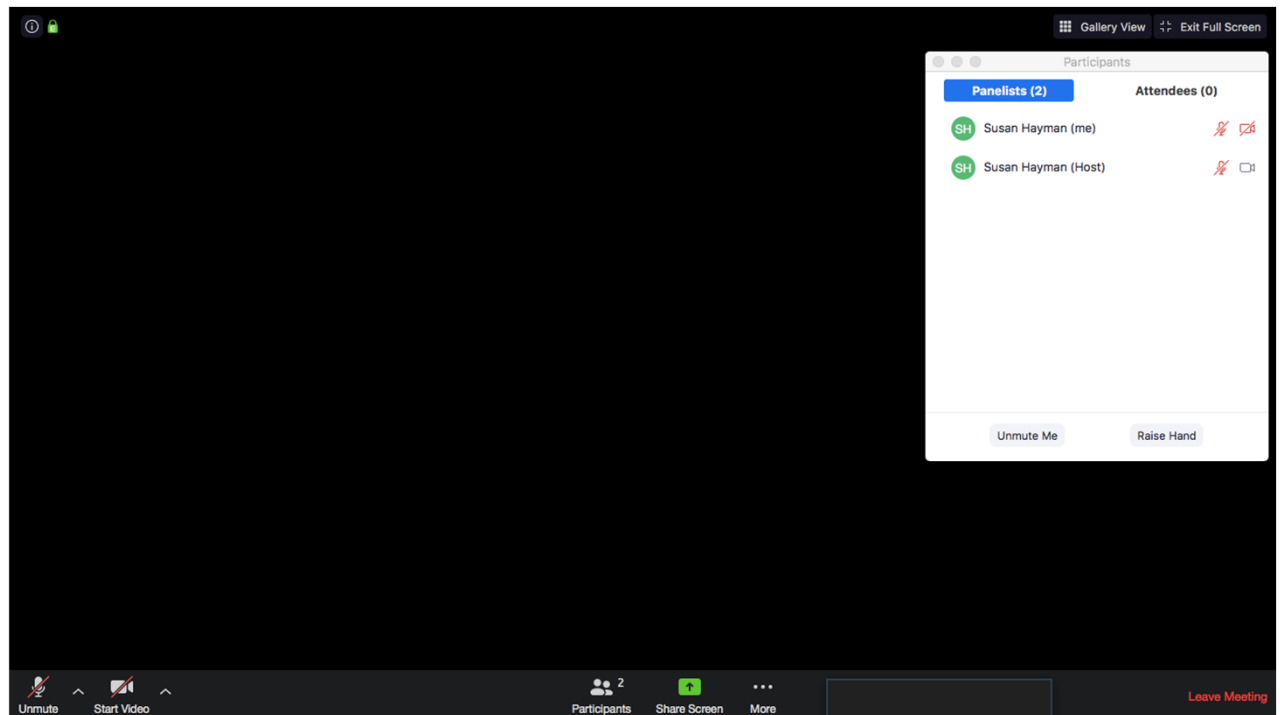

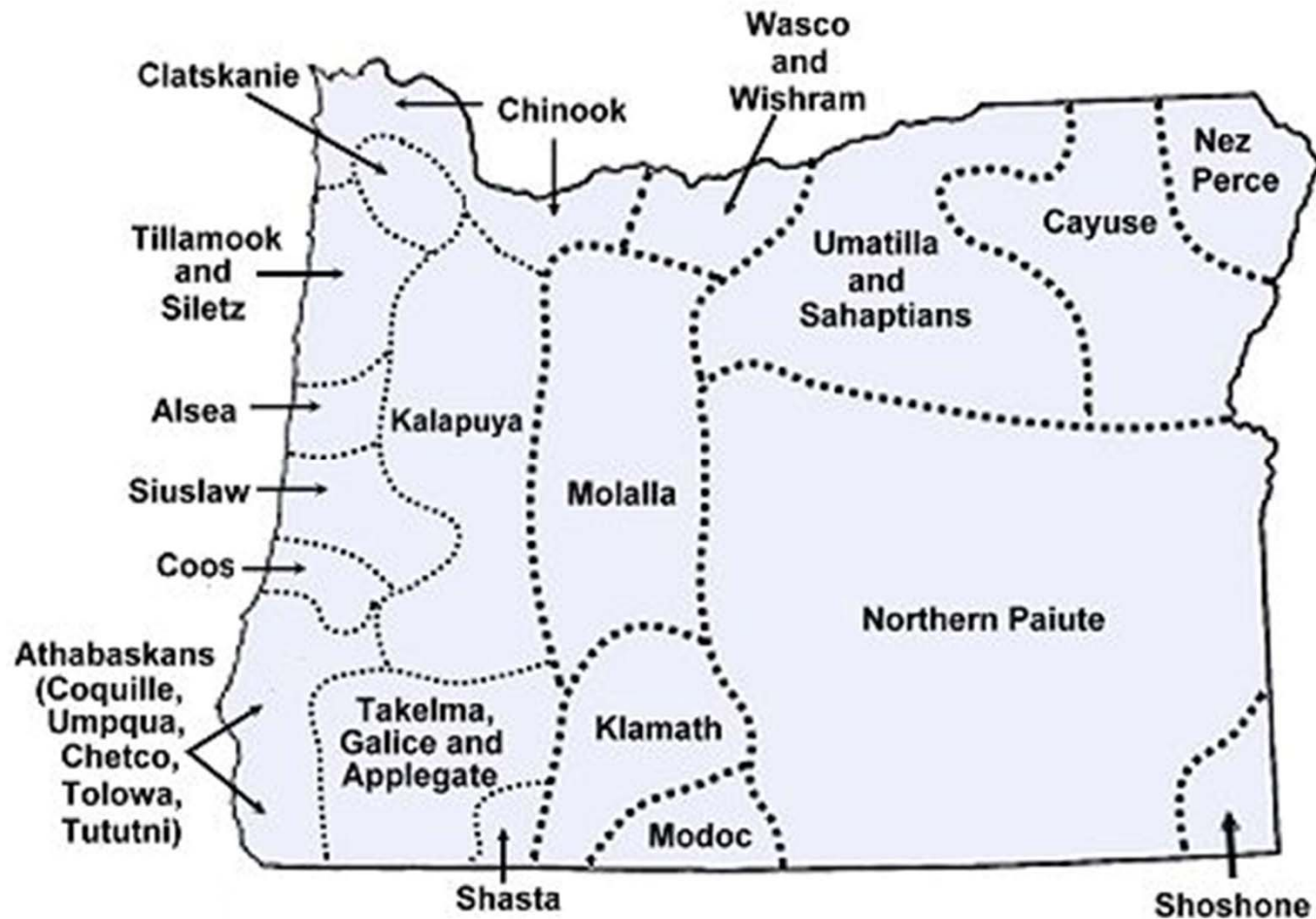

- » Bring your best thinking into the room
- » Attack the problem, not the person

Listening Session Context

- » **ODOT and partners will listen** to suggestions and requests.
- » **ODOT and partners will be accountable** to address your concerns and the community's feedback as the Project is designed and built.
- » **Think deeply, ask probing questions, challenge assumptions, and push boundaries.**
- » **I will center specific voices** if I deem necessary.



Centering Exercise

- » Close your eyes or gaze softly downward
- » Feel the chair under your legs
